What is a campaign



A campaign is when people decide they want to work together to make something better.

Charities campaign for things to get better for their members.



A campaign is organised.

This means that the people who lead the campaign decide together what they should do.

A campaign usually has a name.

Our campaign is called "Our Voice Our Rights"



Some campaigns are short.

It all depends on what the campaign is trying to make happen.

Our Voice Our Rights is about making Scotland the best country in the world for autistic people and people with a learning disability.

There are 120,000 people who have a learning disability in Scotland.

Some people think it is really closer to 175,000.

There are around 56,000 autistic people in Scotland.



Our Voice Our Rights is about making sure that autistic people and people with a learning disability are listened to and have their rights respected.



The campaign is asking for the Scottish Government to create a new position within the Scottish Government.

This person would be called the "Autism and Learning Disability Commissioner"

How did the campaign start?



Charities speak up for their members.

Every charity speaks up for different groups of people.



Sometimes different people can benefit from the same thing.

We think autistic people and people with a learning disability would benefit from having an Autism and Learning Disability Commissioner in Scotland.



The charities decided that they would work together to tell people why having an Autism and Learning Disability Commissioner was a good idea for all of their members and their families.



How did the campaign start?



In May 2021 Scotland will hold an election.

This will be the chance for people in Scotland to vote for who they want to be their MSPs in the Scottish Parliament.



This can be a good time to campaign.

It is a chance to speak to people who want to become MSPs and ask them to promise to support our ideas that will make things better.



We are asking them to stand up for autistic people and people with a learning disability.

We are asking them to say that they support our idea to set up an Autism and Learning Disability Commissioner.

Scotland would be the first country in the world to have an Autism and Learning Disability Commissioner.



The Commissioner would be there to stand up for the rights of autistic people and people with a learning disability.



They would help people access the services and the support that they need.

They would speak up for autistic people and people with a learning disability.



What is a Commissioner?



The Commissioner would be an important position.

The Commissioner would help autistic people and people with a learning disability get the services and the support that they need.



There have been lots of government reports that say how things can be made better for autistic people and people with a learning disability.

These reports suggest things that need to change to make life better for autistic people and people with a learning disability.



The campaign says that a Commissioner would help to make sure that what government reports say should happen really does happen.
